Non-transferable bid documents shall be available in 3 (three) parts namely: (1) Part-I - Containing Bid Guarantee & Bid Proposal letter, (2) Part-II - Containing Pre Qualification data & Deviation Statement & (3) Part-III -Containing Condition of Contract (Vol-1/2) and Technical Specification in 2 (two) parts from the office of the Executive Engineer(Elect), Namsai Electrical Division, Department of Power, Namsai on above specified details on all working days. The Proposal bidders shall have to apply for the bid document on Contractor's/firm's printed letter pad with details postal address, telephone No, Mobile & Fax No and e-mail ID etc enclosed with the documents of qualification under the following general information and basic qualification requirements.

General information & basic qualification requirement:

1. Prospective purchaser of bid documents shall have to furnish letter of authority & proof of being an authorized representative of the bidder.
2. Prospective bidder(s) shall have to furnished the following in original:
 - i. Valid GST Registration No., Manufacturer Certificate, Dealership Certificate wherever applicable.
 - ii. Latest Income Tax & Sale Tax Clearance Certificate from the competent authority.
 - iii. Documentary evidence that they executed similar nature of work with equivalent amount in a Single Order in the last three years which commensurate to tender package being purchased.

- iv. The intending tenderer's should append details and expertise with their application for issue of tender papers. The tender papers should be issued only after ascertaining from the issuing authority about their expertise and experience in the specialized field.
- v. The bidders must have experience certificate against the work as indicated in the above table, under any Utility like PGCIL, State Power Utility having successfully erected at least i) 10 Kms of 33KV, 11KV class or above voltage class of line, ii) distribution sub-stations of 100KVA, 63KVA, 25KVA, 16KVA 11/0.415KV grade i/c LT line iii) 20 mtr long high mast lighting tower during the last 7 (seven) years as on the date of bid opening and which must be in satisfactory operation for at least two (2) years as on the date of bid opening, such certificate should be signed not below the rank of Executive Engineer. Such authentic proof of documents like award letter and successful completion certificate of owner must be enclosed.
- vi. The bidders must be ISO-9001-2008 certified preferably.
- vii. The application for bid document accompanied with cost of bid document in cash or demand draft along with a copy of above supporting documents has to be addressed and submitted to the following address:

- viii. The bid documents shall neither be sold nor accepted for opening through postal or courier service.
- ix. The Department of Power shall not be responsible for any form of delay in receiving the bid document in time and no extension of time shall be entertained on such account.
- x. The bid guarantee (Earnest money) in the form of FDR tentatively shown above in the table shall have to be deposited along with the bid document and no other financial instrument shall be accepted.
- xi. Department of Power reserves all right to cancel/withdraw the bid in full or in part without assigning an reason for such decision and to place order in full or in part. Such decision will not incur any liability whatever on the part of Department of Power consequently.
- xii. While submitting the tender documents, Bidders' shall submit the bid documents in 5(five) copies including original.
- xiii. The District based Entrepreneurs and Professionals must be duly registered under the Arunachal Pradesh Contractors Enlistment Rules 2008 in the appropriate class with valid registration and validity notified vide No. SPWD/W-66/2012/314 Dt. 13/08/15.
- xiv. The district based entrepreneur posses class-I license and executed similar amount of work either through Sub-contractor work and etc. may also be allowed.
